KPPA provides many benefits not only to its members but also to their agencies.

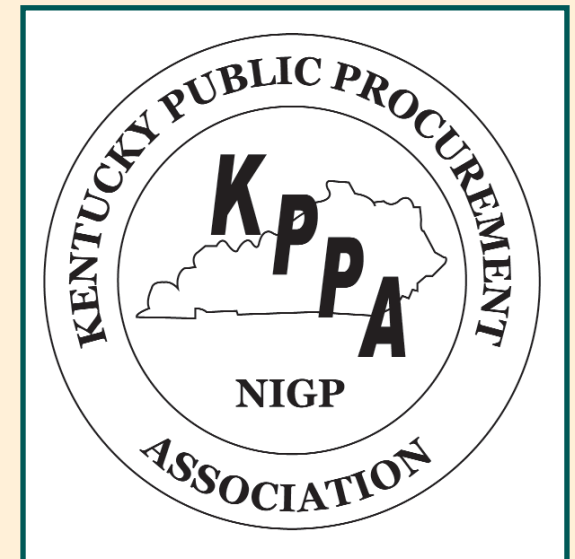
